1. DEFINITIONS OF TERMS

1.1. "Cruise" is a 10-night holistic cruise and seminar-at-sea offered by Neil Gaur of Portal to Ascension and Susan Shumsky of Divine Travels, named "Mystery School at Sea Cruise," which will occur on the Celebrity Infinity cruise ship, March 20 to 30, 2026, sailing round-trip from Athens to Nafplio, Iraklion, Rhodes, Kavala, Thessaloniki, and Ephesus.

1.2. "Shore Excursion Organizers" are Susan Shumsky of Divine Travels, Neil Gaur of Portal to Ascension, and their representatives: Luxury Travel Destinations, Shore Excursions Group, any contracted local tour operators involved in facilitating the Mystery School at Sea Shore Excursions, and Celebrity Cruise Line.

1.3. "Cruise Participant" is a person attending the Cruise.

1.4. "Shore Excursions" are exclusive, custom-designed group tours at selected port stops during the Cruise, Pre-Cruise and Post-Cruise, offered by the Shore Excursions Organizers.

1.5. "Special Event Descriptions" is the official list of special paid workshops offered by the Shore Excursions Organizers on the cruise ship, described at <https://mysteryschoolatsea.com/2026-facilitators/>

1.5. "Shore Excursions Descriptions" is the official list of itineraries, inclusions, and activity details for each Shore Excursion, described at: <https://mysteryschoolatsea.com/excursions/>

1.6. "Cruise Registration Form" is the online form used to register for Cruise attendance, posted at: <https://register.spiritualityproducts.com/>

1.7. "Shore Excursions Registration Form" is the dedicated registration form, posted at <https://register.spiritualityproducts.com/excursions-registration/> for booking Shore Excursions and Special Events for the Mystery School at Sea cruise.

1.8. "Shore Excursion Participant" Refers to any individual who registers for one or more Mystery School at Sea Shore Excursions and/or Special Events via the official registration form at <https://register.spiritualityproducts.com/excursions-registration/>

1.9. "Mystery School at Sea Shore Excursions Agreement"

1.10. "Mystery School at Sea Shore Excursions Fee" Refers to the payment made by the Shore Excursion Participant for one or more excursions and/or Special Events at <https://register.spiritualityproducts.com/excursions-registration/>

1.11. "Cruise Itinerary" is the planned travel route of the Cruise: Athens → Nafplio → Iraklion → Rhodes → Kavala → Thessaloniki → Ephesus → Athens.

1.12. "Cruise Schedule" is the tentative schedule of on-board seminar activities at sea, available at: <https://mysteryschoolatsea.com/seminar-daily-schedule/>

1.13. "Cruise Sailing" is the Celebrity Infinity ship's scheduled cruise that will occur from March 20 to 30, 2026.

2. CONDITIONS OF BOOKING

Payment by a Shore Excursion Participant for participation in one or more Mystery School at Sea Shore Excursions and/or Special Events constitutes full acceptance of, and agreement to, all terms and conditions outlined in this document.

3. WAIVER OF LIABILITY

The Shore Excursions Organizers act solely as coordinators for the Mystery School at Sea Shore Excursions, including all reservations and operational logistics. Participation is undertaken with the explicit understanding that the Shore Excursions Organizers shall not be held liable for any delay, theft, damage, injury, act of terrorism, cancellation, or other irregularities, however caused.

The Shore Excursions Organizers assume no responsibility or liability for the following, and will provide no refunds or reimbursements for the following:

1. Any changes or delays in transportation schedules, missed carrier connections, or other third-party services.
2. Injury, loss, or damage to persons or property, regardless of cause.
3. Additional expenses resulting from fluctuations in exchange rates, tariffs, or changes to the itinerary.
4. Defects in any vehicle or the acts or defaults of any company or individual engaged in transporting Shore Excursion Participants or executing any part of the excursions.
5. Costs or losses incurred due to illness, inclement weather, strikes, war, terrorism, epidemic, pandemic, quarantine, or any other force majeure occurrences.
6. Losses arising from cancellations of Shore Excursions or Special Events, either by the Shore Excursion Participant or by the Shore Excursion organizers.
7. Changes or substitutions in the Shore Excursion itineraries or Special Event workshops.
8. Physical, mental, or emotional injury sustained as a result of participating in any Mystery School at Sea Shore Excursion or Special Event.
9. Shore Excursion Participant's disappointment, dissatisfaction, or unmet expectations regarding the experience of the Mystery School at Sea and any of its Shore Excursions and/or Special Events.

4. CHANGES IN ITINERARY

Modifications to the tentative itineraries outlined in the Mystery School at Sea Shore Excursions Descriptions and/or Special Event Descriptions are to be anticipated. The Shore Excursions Organizers reserve the right to make any changes deemed necessary for the successful operation of the Mystery School at Sea Shore Excursions and/or Special Events, with or without prior notice. Such changes will not entitle the Shore Excursion Participant to any partial or full refund of the Shore Excursion or Special Event fees.

5. NO GUARANTEES

No guarantees, whether stated or implied, are made by the Shore Excursions Organizers regarding any aspect of the Mystery School at Sea Shore Excursions. Dissatisfaction or

complaints will not result in any refund, in whole or in part.

Specifically, the Shore Excursions Organizers make no guarantees concerning:

1. The number of Shore Excursion Participants or their age demographics.
2. The attendance or participation of any specific speaker or presenter on the cruise or during any Special Event and/or Shore Excursion.
3. The amount of time any presenter, speaker, or guide may spend personally leading a given Shore Excursion at ports or Special Event on the ship.
4. Visiting locations depicted in promotional photographs and videos or any likeness between the actual sites and those shown on the Mystery School at Sea Cruise website.
5. The nature, depth, or quality of any subjective experience during the Shore Excursions and/or Special Events.
6. Any other specific aspect or outcome of participation in the Mystery School at Sea Shore Excursions and/or Special Events.

6. RATES

Nonrefundable participation fees for the Mystery School at Sea Shore Excursions and/or Special Events are published on the official Registration Form here:

All published rates are valid only for the time period specified. Once a Shore Excursion Participant has paid the full applicable fee, the rate is fixed and nonrefundable, and it will not be altered for any reason. However, the Shore Excursions Organizers retain the right to offer alternative rates—including discounts or promotional pricing—to other Cruise Participants at any point prior to or during the Cruise.

7. MYSTERY SCHOOL AT SEA SHORE EXCURSIONS FEE INCLUDES

The Shore Excursions Fee per person includes the following:

1. Round-trip transportation and an English-speaking professional guide for the designated Shore Excursion.
2. Program elements, snacks, drinks, meals, and free time *only* as explicitly outlined in the official Mystery School at Sea Shore Excursions Descriptions here:

8. MYSTERY SCHOOL AT SEA SHORE EXCURSIONS FEE DOES NOT INCLUDE

Unless specifically listed in the official Mystery School at Sea Shore Excursions Descriptions, the following are not included in the Shore Excursions Fee:

1. Meals, snacks, and beverages not mentioned in the Mystery School at Sea Shore Excursions Descriptions.
2. Gratuities for guides.
3. Gratuities and taxes on personal purchases or services.
4. Insurance of any kind, including but not limited to: travel, health, accident, baggage, cancellation, or life insurance.

5. Costs incurred by independently booked guides, vehicles, or transportation services not arranged through Mystery School at Sea Shore Excursions.

9. CANCELLATIONS

All payments for Mystery School at Sea Shore Excursions at port and Special Events on the ship are strictly nonrefundable, regardless of the reason for cancellation. The only exception to this applies if a Shore Excursion or Special Event is canceled by the Shore Excursion Organizers due to insufficient Cruise Participant registration. In such cases, Shore Excursion Participants who have paid for the Shore Excursion or Special Event will receive a full refund.

Shore Excursion Participants are **strongly advised** to purchase comprehensive travel insurance that covers:

1. Personal illness or medical emergencies.
2. Missed excursions due to late arrival.
3. Cruise itinerary changes (e.g., ship not docking at a scheduled port).
4. Excursion cancellation by local tour operators or any other unforeseen events.

If a Shore Excursion Participant is unable to attend a Shore Excursion and/or Special Event due to illness, it is recommended that they obtain written documentation from the ship's Medical Center in order to support any applicable travel insurance claim for reimbursement. Shore Excursion tickets are **transferable**, and Shore Excursion Participants have the right to sell their ticket(s) to another Cruise Participant.

10. RESERVATION RESTRICTIONS

Prospective Mystery School at Sea Shore Excursion Participants with any disability, pre-existing medical condition, or medical history requiring special attention or treatment must inform the Shore Excursions Organizers at the time of booking. It is strongly recommended that such individuals consult with a medical professional before reserving space on any Mystery School at Sea Shore Excursions. Shore Excursion Participants who are unable to travel independently or who require special assistance must be accompanied by a companion capable of providing the necessary support. The Shore Excursions Organizers do not assume responsibility for providing special accommodations or assistance.

11. TRAVEL INSURANCE

All Mystery School at Sea Shore Excursions Participants are **strongly encouraged** to obtain comprehensive travel insurance, including coverage for medical emergencies, accidents, cancellations, or other unforeseen events. The Shore Excursions Organizers carry **no insurance** for Shore Excursion and/or Special Event Participants.

12. SPECIAL REQUIREMENTS

To ensure a safe and enjoyable experience, all Mystery School at Sea Shore Excursions Participants must meet the following requirements:

1. Shore Excursion Participants must be physically and mentally fit to participate in the Mystery School at Sea Shore Excursions.
2. Any Shore Excursion Participant undergoing medical treatment or taking prescribed medication must bring a sufficient supply to last for the duration of the Mystery School at Sea Shore Excursions.
3. Shore Excursion Participants are strongly advised to consult with a qualified medical professional before taking part in any Mystery School at Sea Shore Excursions.
4. The Shore Excursions Organizers are not liable for any health-related issues occurring during or after the Mystery School at Sea Shore Excursions for any reason.
5. The Shore Excursions Organizers are not responsible for lost, stolen, or damaged personal property for any reason.
6. The Shore Excursions Organizers are not liable for any Shore Excursion Participant who fails to return to the ship on time for any reason.

13. PUBLICATION RELEASE

Representatives of the Shore Excursions Organizers may photograph, audio-record, and/or video-record Shore Excursion Participants during the Mystery School at Sea Shore Excursions and/or Special Events. By participating, each Shore Excursion Participant grants the Shore Excursions Organizers the unrestricted right to use and publish such media for promotional or archival purposes, without further consent or compensation. Each Shore Excursion Participant expressly releases the Shore Excursions Organizers and their representatives from any liability connected to such use.

14. RIGHT TO REFUSE SERVICE

The Shore Excursions Organizers reserve the right to accept, decline, or remove any Shore Excursion Participant from the Mystery School at Sea Shore Excursions and/or Special Events at any time, without liability or obligation to provide a refund or compensation. The Organizers are not responsible for any Shore Excursion Participant who voluntarily departs a Shore Excursion and/or Special Event before its conclusion, who engages in activities outside the official itinerary, or who fails to follow the instructions of the Cruise Organizers and local tour guides.

15. SHORE EXCURSIONS REQUIREMENT

Mystery School at Sea Shore Excursions are available exclusively only to guests who meet one of the following criteria:

1. Cruise Participants who have completed the Cruise Registration Form and have either:
(a) paid in full for the Mystery School at Sea Cruise and Seminar-at-Sea, or have
(b) submitted the required non-refundable reservation fee, and have booked through Luxury Travel Destinations.
2. Individuals who are staying in a stateroom with at least one Cruise Participant who has completed the Cruise Registration Form and has either: (a) paid in full for the Cruise and Seminar-at-Sea, or has
(b) submitted the required non-refundable deposit, and has booked through Luxury Travel Destinations.

Individuals who have not booked their cruise through Luxury Travel Destinations are not eligible to participate in any Mystery School at Sea Shore Excursions or Special Events.

16. WAIVER

The Shore Excursion Participant agrees to indemnify and hold harmless the Shore Excursions Organizers from any and all claims, losses, damages, injuries, liabilities, or expenses arising from or related to the Shore Excursions Organizers actions or omissions in connection with this Agreement. This includes, but is not limited to, the costs of defense, including attorneys' fees. By signing this Agreement, the Shore Excursion Participant fully releases the Shore Excursions Organizers and their representatives from any and all responsibility and liability.

17. AGREEMENT

This Agreement may only be modified through the written consent of all parties involved. It constitutes the entire understanding between the Shore Excursion Participant and the Shore Excursions Organizers with respect to the Mystery School at Sea Shore Excursions and Special Events. No other agreements, whether written or implied, exist between the parties concerning this subject matter. The failure of the Shore Excursions Organizers to enforce any provision of this Agreement shall not be construed as a waiver of their rights to enforce that or any other provision. If any section of this Agreement is deemed illegal, void, or unenforceable, such determination shall not affect the validity and enforceability of the remaining provisions.

18. AUTHORIZATION

By submitting the Mystery School at Sea Shore Excursions Registration Form or the Cruise Registration Form online, the Shore Excursion Participant agrees to the following:

"I hereby authorize charges to be processed against my credit or debit card in the amount I indicated on the Mystery School at Sea Shore Excursions Registration Form and the Cruise Registration Form. I fully agree to the terms and conditions outlined in this Mystery School at Sea Shore Excursions Agreement at <https://spiritualityproducts.com/2026-excursions-agreement.pdf>. I understand that charges will appear on my debit or credit card statement under the name "**DIVINE REVELATION**," "Celebrity," or both, and I authorize these charges to be processed in accordance with the rates I selected during registration. I acknowledge and accept that all payments made for the Mystery School at Sea Shore Excursions are strictly nonrefundable for any reason."

19. PERSONAL RESPONSIBILITY

By registering for Mystery School at Sea Shore Excursions and/or Special Events at <https://register.spiritualityproducts.com/excursions-registration/>, the Shore Excursion Participant affirms the following:

“I acknowledge that I am solely responsible for my personal safety, health, and overall well-being (mentally, physically, and emotionally) during and after the Mystery School at Sea Shore Excursions and/or Special Events. I hereby release the Shore Excursions Organizers, their representatives, employees, assistants, and affiliates from any and all liability for injuries or damages, whether physical or mental, that I or any of my family members may incur as a result of participating in the Mystery School at Sea Shore Excursions and/or Special Events.

“I agree and accept that all Shore Excursion and Special Events fees that have been charged to my credit or debit card (or any other form of payment) are 100% nonrefundable for any reason.

I understand that no health, travel, or accident insurance is provided by the Shore Excursions Organizers, and that it is my responsibility to secure such insurance independently if I desire.
